



SITUATIONAL SUMMARY:

Vaccination rates in **Miller** (21.1%), **Morgan** (26.5%), and **Camden** (32.3%) counties are below the state rate of 39.0%. Experts say at least 70%-80% of people, depending on type of variant virus, need immunity to provide the best chance of minimizing spread within a community.**

In recent weeks, neighboring counties to the Southwest have experienced a surge in COVID-19 cases and hospitalizations. Delta variant has been identified in many cases and is believed to be contributing to the increase. Cases in Miller, Morgan, and Camden counties are also rising with 38, 41, and 81 respectively in the past week. Disease spread from Southwestern Missouri to the Lake of the Ozarks region is expected. Forecasted rates in **Miller, Morgan, and Camden counties could be 3 or more times higher in the coming weeks.*****

Delta Variant Update:

- Delta cases are on the rise in your area and in Missouri.
- The Delta variant appears to spread more easily and poses higher risk of hospitalization than prior strains.
- Social distancing and other precautions remain important.
- Vaccination still shows very effective protection.

Value of Vaccination for Individuals:

- All approved vaccines are very effective, even against new variants.
- There is no cost for the COVID-19 vaccine, even if you are uninsured.
- Fully vaccinated individuals are less likely to miss work, school, or social functions due to illness.
- Fully vaccinated individuals are not asked to quarantine when exposed to COVID-19 and not symptomatic.

Value of Vaccination for Workplaces/Communities:

- Helps prevent or reduce outbreaks that create high absenteeism in businesses and hamper community social events.
- Minimizes hospital resources for COVID-19.
- Protects nursing homes and other vulnerable people.

Safety:

- Administered safely to millions of people in the U.S. under intense safety monitoring.
- Authorized quickly, without ignoring safety checks, by cutting 'red tape'.
- Protects people from getting sick and especially prevents severe illness from COVID-19.
